

## CCBC Education in BC Statement – July 11, 2015

### Preamble:

The College of Chiropractors of BC (CCBC) has considered an appropriately informative statement on the matter of Chiropractic Education in BC that may be communicated to the registrant community, government or the general public, as may be needed from time to time.

### Resolution:

Be it Resolved, that the CCBC has supported from the outset the Motion of November 8, 2008, which authorized the CCBC to increase annual dues in the amount of \$500.00 commencing July 31, 2009 in support of Chiropractic Education in BC initiatives\*. (\*defined as establishment of a School of Chiropractic)

### Further,

Be it Resolved, that on February 12, 2014, CCBC's Board of Directors reaffirmed that annual dues collected for Education in BC, would be placed in a Segregated Fund and remain in said fund earning interest, unless the Education in BC initiative should not proceed in any form.

### Further,

Be it Resolved, that the CCBC Board of Directors continue to support the Education in BC initiative. Delays have occurred in moving the initiative forward and these delays are inevitable due to the magnitude and numerous partnerships necessary to bring about such a project.

### Further,

Be it Resolved, that through early discussions about Education in BC being established, it was felt that Simon Fraser University information supported a chiropractic school at SFU Burnaby Campus, with the approval of SFU's Board of Governors (June 2014).

### Further,

Be it Resolved, that the name most likely to be chosen for the Chiropractic Education in BC, is PACIFIC ACADEMIC INSTITUTE OF CHIROPRACTIC (PAIC).

### Further,

Be it Resolved, that CCBC's Board of Directors confirm in such eventuality that neither the Pacific Academic Institute of Chiropractic nor, any other Chiropractic School in BC proceeds, a refund of residual dues and residual earnings will be returned to all chiropractors who are or were registered, during such time as their Education in BC dues were paid.

Be it Resolved, that CCBC's Board of Directors confirm and advise of a proposed disbursement date, in such eventuality that neither the Pacific Academic Institute of Chiropractic nor, any other Chiropractic School in BC proceeds, a refund of residual dues and residual earnings, will be returned to all chiropractors who are registered as full or non-practicing members at the time of the decision not to proceed during such time as their Education in BC dues were paid.

Further,

Be it Resolved, notification will be made to all other chiropractors who had dues previously paid and will be refunded upon application to the College. All residual dues and residual earnings, will be retained in the Education in BC Segregated Fund for a specified period of time until either dispersed for approved educational initiatives or as previously noted.

Be it Resolved, that the creation of new entities like the Education in BC Foundation, or the Pacific Academic Institute of Chiropractic or a Board of Directors of any new entity, will not alter or reduce the CCBC's Board of Directors' governance role to ensure that all residual dues and residual earnings collected for Education in BC be used for the stated purpose of chiropractic education in BC (as defined above), until such time as the funds and earnings are turned over to a new entity or institution, as may be legally sanctioned.
